The Catalan coast is in a limited situation: 43.3% of the population of Catalonia lives in coastal municipalities that represent 6.7% of the Catalan territory, where a very important part of the country's economic activity is concentrated. Eighty-one percent of the coastal strip is urbanized and there are plans to build 120,000 more houses.

Given this unsustainable situation of real estate and urban development pressure on the land, it is essential to find ways of preserving and adapting the land to this biophysical and socio-economic reality and to ensure the sustainability of the Catalan coast.

11.40h - 11.55h A new tool for the protection of the Catalan coastline: The creation of the *Conservatori del Litoral*

The *Llei de protecció i ordenació del Litoral* (July 2020) established the mandate for the Government of the *Generalitat de Catalunya* to create, within one year, the *Conservatori del Litoral de Catalunya*. This is a specific agency with coastal planning and management functions, provided with the competences and resources to take the necessary measures to conserve and restore the coastline.

There is currently an increasing concentration of renewable energy projects in agricultural and natural sites of high ecological value, mostly located in the south of Catalonia (Tarragona area). This situation clearly goes against the directives of Law 16/2017, on climate change, which establishes that renewable energies must be developed, as a priority, in areas that have already been altered by human activity.
